San Tan Montessori, LLC, has a 10-month academic year for all classes. Tuition is based on the full-year fee which has been divided into 10 equal monthly payments for your convenience. Full tuition of 10 months can be paid upon the program start and will be given a 10% discount when paid in full. Payments are not considered "monthly" charges but are the full year's tuition divided into a 10 month period. Payments enrolled on the 1st of every month, beginning July 1st and ending April 1st. Tuition is during the school year months. We do give a 4 day grace period to pay, and on the 5th day of late payments will incur a non-refundable \$10 late fee. Payments are made by month and will cause a disruption in services. Tuition is not refundable or pro-rated for students (except for illness, vacation, holidays, withdrawal, dismissal, or otherwise). Multiple students from the same family will be reduced at a rate of 10% if multiple students from the same family are enrolled in our preschool program.

Lunches are not provided by the school as part of any program, yet lunches purchased in advance at our school lunch area or brought from home. The \$100.00 lunch fee is not included in the half-day program. If your child is enrolled in the half-day program and would like to participate in the lunch hour, there is an additional cost of \$10.00 per month.

Payments not received by the 10th day will incur a \$25 non-refundable late fee. Tuition \$1 day thereafter if non-payment will incur an additional 10% fee of non-payment due. The Parent agrees to pay the above stated tuition and fees as specified. The timing of the expense with respect to the month of non-payment of any funds due hereunder. San Tan Montessori, LLC, reserves the right to cancel the agreement and to exclude the child from participation in the instruction, and unpaid amounts could result in being sent to a collection agency. In the event that a business necessary for San Tan Montessori, LLC, to employ a collection agency and/or attorney for collection of any amounts due under the agreement, parent agrees to pay all the costs and expenses incurred by San Tan Montessori, LLC, whether or not litigation is initiated, including, but not limited to all attorney fees, attorney fees, and court costs incurred by San Tan Montessori, LLC. All debts if accounts will be sent to a company or lawyer employed by the school for collections management. If payment is still delinquent at the end of the second month the student's attendance will be suspended on the 1st day of the next month thereafter. This agreement may be terminated by parent upon 10 day written notice to the school by the parent. Parents will be responsible for payment of tuition and fees for only days following the after receiving the written notice of withdrawal. Parent agrees that withdrawal or dismissal of their children after the execution of this agreement, whether as a result of academic, medical, relocation due to parent's occupation, financial difficulty, address, disapproval, address, disagreement with teaching style, school policies, or otherwise, does not release the parent of the responsibility of fulfilling the school's financial policy. (Enrollment by San Tan Montessori, LLC). The school reserves the right to discharge, at any time, any child, who, in the opinion of the Administration and their teacher is not benefiting from the instruction or whose behavior is detrimental to the program of the school. The recommendation and observations of the school's teacher are taken into consideration and withdrawal is not considered unless the school can see that it is in the best interest of the student, and/or the classroom. Tuition considerations are at the discretion of the administration to be determined at the time of dismissal. Dismissal: Parent has consented any pertinent information in writing to San Tan Montessori, LLC. Pertinent information includes any physical, mental, or emotional condition of the child or any other matter, which may affect the child's conduct and/or participation in school. Parent agrees by signing this agreement that the child is physically capable of participating in all aspects of the Montessori program chosen.
